

Entry conditions, Emirates Arabian Horse Global Cub Vilhelmsborg – Denmark



Entry conditions	Open to horses that are registered at birth in a WAHO recognized studbook of a continent (or geographical area) where the show is organized
Entry restrictions	 Breeder and owner must be person(s) with the European nationality and citizenship.
	 Breeder and owner must be a company exclusively owned by person(s) with the nationality and the citizenship of one of the countries of the continent or geological area where the show is organized
	 Breeder and owner must be a Stud farm exclusively owned by person(s) with the nationality and the citizenship of one of the countries of the continent or geological area where the particular show is organized.
	 Breeder and owner must be a Stud farm exclusively owned by a European government (state stud).
	Breeder does not need to be owner of the horse.
	 No co-ownership is allowed except the immediate family members as clearly stated in the passport.
	Entries of leased horses will not be accepted.
	• Studbook registration of ownership must be at least 6 months before the date of the show.
	• Owners, who produce more then 15 foals a year (during last three years prior to the show), are not allowed to enter their horses in the show. Declaration, confirming the number of bred and registered horses during the last three years, must be signed by the horse owner, and must be sent together with the Entry form.

- Individual horses are allowed to participate in only one of the EAHGC shows per season, except the EAHGC Final.
- Title Show or A Show Champion Gold and Silver medal winners (or winners of similar category of shows in the region/continent) are not allowed to take part in any of the EAHGC shows for the rest of that calendar year and the two calendar years following, unless the horse has passed from a yearling to junior, from junior to a senior category.
- Anybody entering a horse which does not fulfill entry conditions/restrictions or an overqualified horse, will be liable to a fine of €600. The horse will be disqualified and will be not eligible for any prize-money rewards.

Halter Classes - Point system: 5 topics - 10 points with half points. Type - Head & neck - Body - Legs - Movement

Head and neck will be judged as individual criteria. Points for head and for neck will be averaged to give one score for b) head & neck.

Walk and trot will be judged as individual criteria. Points for walk and for trot will be averaged to give one score for e) movement.

Medication control

Medication testing of all gold Medal winners is not compulsory. Any horse may be tested at the discretion of the DC. The organizers of the show should arrange for an ECAHO approved sampling vet to be available, should the Disciplinary Committee request that a drug test be carried out. All medication testing will be conducted according to ECAHO Rules for Medication Control.

Rules for all Championships: ECAHO Blue Book Open method - Horses placed 1st, 2nd in their classes are qualified for their respective championships.

For Ties in Qualifying Places:

Methods of Judging In the event of a tie in the qualifying places of a class, the higher place will be given to the horse with the most points for type. If there is still a tie, the higher place will be given to the

horse with the most points for movement. Failing a decision on either of these, one judge chosen by ballot will name his preference.

Rules for the championships:

The following championships should be awarded:

Junior Female Championship Junior Male Championship Senior Female Championship Senior Male Championship

Rules for ties in Championships:

in the event of a tie in the championships, the higher place will be given to the horse with the highest total points in the qualifying classes. If the highest and lowest points are eliminated, only the remaining points for total, type and movement are considered in the tie break. If there is still a tie, the rules for ties in qualifying places will be applied.

Price money and rewards

	For 2024 number of classes with prize-money rewards is 10 classes. Classes: 1 5. place: 5.000 AED Championship: Trophies (Gold, Silver, Bronze) All prize-money rewards will be transferred to the horse owners bank accounts. A list with the names of all winners and their bank details will be provided by the show organizers. Registered owner of the winning horse must be the owner of provided bank account.
